FIRST AMENDMENT FOOD SERVICE CONCESSIONAIRE AGREEMENT

THIS AMENDMENT is made between THE CITY OF LEESBURG, FLORIDA, a Florida Municipal Corporation, whose address is 501 West Meadow Street, Post Office Box 490630, Leesburg, Florida 34749-0630 ("CITY"), and BEACON COLLEGE, INC., 105 East Main Street, Leesburg, Florida 34748 ("CONCESSIONAIRE").

WITNESSTH:

On January 12, 2015 the CITY and CONCESSIONAIRE entered into an Agreement for Concessionaire Services to provide certain concessions at the Leesburg Public Library.

The CITY and the CONCESSIONAIRE desire to execute this Amendment Number One ("Amendment") to the Original Agreement, modifying said Agreement as described herein.

NOW THEREFORE, for and in consideration of the mutual covenants and promises contained in the Agreement, the CITY and the CONCESSIONAIRE do hereby agree as set forth below:

- 1. **Recitals**. The above recitals are true and correct and are incorporated herein.
- 2. <u>Amendment.</u> The Parties agree to extend the term of the Agreement through September 30, 2024 as permitted by the original Agreement. (Reference Paragraph 2 of the original agreement.)
- 3. <u>Modification</u>. Except as specifically modified by this Amendment, all terms and conditions of the prior agreement shall continue in full force and effect as originally executed. Nothing herein shall be deemed or construed to amend or modify any other contract or undertaking between the City and Contractor other than as defined above.
- 4. <u>Counterparts.</u> This Agreement may be executed in multiple counterparts, each of which may be considered an original, but all of which together shall constitute but one and the same instrument. This Agreement when signed by a party may be delivered by electronic mail or facsimile transmission with the same force and effect as if the same were an executed and delivered original, manually-signed counterpart.
