#### **Questions and Answers:**

1. Per the walk through, it was determined that the best access to get the signs for the upper deck left field façade inside the stadium would be to set the crane truck on the road (or sidewalk) down below the "All You Can Eat" area. Please advise of your approval to mobilize and set up the crane truck in this area.

MSA did not make any determinations on best access for the signs. It is would be for the contractor to suggest a method and for MSA to approve. If a contractor would like to use Camden Street for a crane that would be OK, but they would need to handle road and sidewalk closure with the City of Baltimore, etc. on their end.

2. Will the old ad copy, provided by the Orioles, be provided in digital artwork format for the replacement panels?

The plan would be to use the existing art work. If for some reason it could not be reused, artwork would be provided in a digital format.

3. In Addendum No. 4, Item#2 – it state to reuse the existing artwork from the previous panel. **Questions:** Which previous panel or do you mean all the flexible face panels? If all the flexible face panels, do you mean using the existing panels just like the UTZ panel?




11. Are the new sign cabinets being installed in the same locations as the old ones that contractor will remove or at a new location?



We want all new.









# SIGN PLAN VIEW
